

## Frequently Asked Questions:

### **Why do we have an Annual Giving Campaign?**

St. Paul's is a pledging community, which means that the funds we need to operate come primarily by the generosity of financial commitments from our members. Some follow the biblical principle of tithing, giving ten percent of their income to the church, while others commit a lesser amount. Some give weekly or monthly while others make a one-time annual gift. Everyone is asked to give as they are able. Each financial pledge is a blessing and whatever you pledge is much appreciated!

### **Why should I pledge instead of just giving?**

Making a commitment in advance enables us to come up with a budget and plan for the coming year. We are grateful for every gift. In order to do responsible fiscal planning, we need to have an idea of how much will be donated in the coming year so we can prepare and make commitments regarding staff, facilities and programs.

### **How will my pledge be used?**

Pledges fund our operating expenses. Your pledge makes it possible for us to pay salaries, maintain our facilities, run our office, print our bulletins, present our programs, and serve this community and the world through various kinds of outreach. For a detailed look at how the money will be spent, we are happy to provide you with a copy of this year's operating budget.

### **Do pledges alone bring in enough funds to meet our operating expenses?**

No. We also depend on funds brought in by leasing of portions of our property. We currently have four tenants (La Famiglia Preschool, VSAGE Charter School, Kindermusik, and a family that rents our house on San Pablo Street). Still, this is a big campus, and we have lots of space available. Though we actively searched for over two years, looking for another school needing multiple classrooms, we didn't find one. Now we are in the process of converting the Gooden Center back into residential space. We look forward to being able to offer it as housing, which is difficult to find in this neighborhood. It will bring in a steady income for the church and help to meet an important need in the community. Depending on how things develop as we work our way through this phase of the pandemic, we may convert the Youth Center (on the corner of St. Paul's Drive and San Pablo) as well. Because of the lack of lease income, we are running a deficit budget and using savings to make up the shortfall. We hope these actions will help generate the income we need so that we can operate a balanced budget.

**How are Legacy Gifts used?**

On occasion, we are blessed to receive gifts from parishioners who have remembered St. Paul's in their estate planning. These legacy gifts are used for special purposes and help us accomplish things that are only possible because of their generosity. If you would like assistance in arranging to bless St. Paul's with such a gift, we would be most grateful. Please contact the church office.

**How much should I pledge?**

This is a personal decision and one that is between you, your family and God. We invite you to pray about it. If you are not sure where to start in considering your pledge commitment, you may want to compare your other financial commitments to what you pledge to your faith community. For instance, consider what you might spend on fast food, coffee drinks, or other optional expenses for a year, versus your gift to the church. The biblical standard for giving is to tithe (give 10%). The church suggests working toward the tithe if you can. Whatever you do, know that God's blessing will be upon your prayerful decision.

**Should I consider increasing my pledge this year?**

Discerning what we give back to God out of all our blessings is an important way we move forward on our journey of faith. God loves us where we are, but also calls us to grow from there. In this time of the COVID-19 Pandemic, the church needs your pledge more than ever! We are grateful for pledges of any amount. If you are already giving all you can, we thank you. If you might be able to do more, we encourage you to consider moving one or two percent closer to the tithe. The practice of tithing ten percent of our income to our faith community is a concrete and meaningful way that we can put God first in our lives.

**How do I make a pledge?**

Please think and pray about this important decision, and then let us know by completing a pledge card or simply communicate the amount of you'd like to pledge in any way that is convenient for you – mail, call, email, etc.

**What if my financial situation changes? Can I change my pledge?**

If it becomes necessary to change your pledge during the year, simply contact the church office. Your pledge can always be changed.
